SUPPLEMENTARY REGULATIONS

EVENT - **COBHAM DRIVE-IT-DAY AUSTIN SEVEN CAR TRIAL**
STATUS - **CLUBMAN**
VENUE - **COBHAM PARK FARM, SURREY (M.R. 187/109589)**
DATE - **SUNDAY 28th APRIL 2019**

1. The 750 Motor Club (Brooklands Centre) will organise the "Cobham Drive It Day Austin Seven Car Trial", a Clubman permit event, at Cobham Park Farm, Downside Road, Cobham, KT11 3ND on 28th April 2018 ("Drive It Day").
2. The meeting will be held under the General Regulations of the Motorsport UK (incorporating the provisions of the International Code of the FIA); these Supplementary Regulations and any further instructions that the organising club may issue for the event.
3. MotorsportUK's Clubmans Permit No 110188 has been issued for this event.
4. The event is open only to fully elected members of the 750MC, VSCC and PWA7C. All drivers must produce a valid Club membership card (Other than those under 18). Drivers aged 14 or over are eligible but if they do not hold a full RTA Licence they must be accompanied by a passenger who holds a full RTA Licence and is an experienced trials driver who holds a valid Club membership card. Front passengers under 16 (minimum age 12) will not be required to sign on but must produce a letter of consent from a parent or guardian at signing on, and this letter will be retained. See para 19(iv) for rear seat passengers in saloons. Double Entries will be accepted.
5. The event is a round of the 750 MC Austin Seven Championship. This is the event's 38th year and has been held nearly every year since 1978.
6. PROGRAMME

Scrutineering starts at	09.00 at Cobham Park Farm Trial Site.
Any competitor not signed on and scrutineered by	10.15 may be excluded.
First car starts at	10.30
Afternoon session starts at	14.00
7. Any changes to the programme will be notified on the day and shown on the display board adjacent to the signing-on point. Cars will not be allowed to start unless they have a valid scrutineering ticket.
8. There will be at least 2 rounds of 6 sections on private land. Details of the sections will be issued after signing on. Public roads will not be used to link sections.
9. The event will consist of 5 classes as follows:
 - i) Austin Seven standard production saloons and tourers
 - ii) Austin Seven unmodified production sports
 - iii) Austin Seven modified saloons and tourers
 - iv) Austin Seven modified sports, specials and others not in i), ii) & iii)
 - v) Austin Seven related guest cars, or "demonstration cars" i.e. not eligible for the above classes.
10. All cars must comply with the 2019 MSA Technical Regulations (as modified in 19. below) and the scrutineer will ensure the entered vehicle is in the correct class.
11. Competitors will be identified by Starting numbers provided by the organisers. These numbers will be issued at signing on.
12. Awards will be presented as follows:

1st in class (subject to a minimum of 3 in class)
2nd in class (subject to a minimum of 5 in class)
3rd in class (subject to a minimum of 7 in class). Class awards will be perpetual.

1st Overall: Challenge Trophy and all other Overall Awards to be presented to the Driver with the lowest overall score to be held for one year recognising that no Driver may win more than one Overall Award..
Roger Boore Trophy: 1st Production Saloon or Tourer from class i) - to be held for one year.
Mike Featherstonhaugh Trophy: for the best newcomer to the Cobham Trial - to be held for one year.
Tony Jones Memorial Trophy: awarded to the best "Junior Driver (Age 14-17)" - to be held for one year.

13. The maximum entry for the meeting, including reserves, is 50; the minimum is 10. The maximum for each class is 25; the minimum is 3. Should any of the above minimum figures not be reached, the organisers have the right to either cancel the meeting or amalgamate classes as necessary.
14. The entry list opens on publication of these Regulations and closes finally on 21st April 2018. The entry fee is £22.50, with a reduced rate of £15.00 for Junior Drivers aged 14 - 17. **Late entries will NOT be accepted and NO entries will be allowed on the day.** All entries must be made on the official form and accompanied by the appropriate fee and received by the Secretary of the Meeting by the closing date. Entries will be selected in order of receipt. Entry fees may be refunded up to 14th April 2018.

16. Provisional results will be published as soon as possible after the end of the event. Any protest must be lodged in accordance with Paragraphs C5.1 – 5.7 of the MotorsportUK 2019 Yearbook General Regulations.
18. Marking and penalties will be as printed in Paragraphs T6 and T7 respectively.
19. All other General Regulations of MotorsportUK apply as written, except for the following:-
 - (i) All competing vehicles in classes i) - iv) shall be Austin Seven powered and have a wheelbase of 6' 3" or 6' 9". Each vehicle shall be capable of being road registered and shall display registration number plates.
 Tyres need to be in accordance with Motorsport UK's Clause T 11.12.6 and furthermore Well-base tyres must have a tread pattern such that the blocks are not more than 10mm deep, nor more than 10mm apart laterally or circumferentially. There must not be an uninterrupted lateral gap between side blocks. Special grip, knobby or hand-cut tread tyres are not allowed. Tyres with bolts or screws penetrating the sidewalls or beads are illegal and will not be allowed; neither will operational security bolts.
 Tyre pressures not less than 7 psi, or as specified by the organisers.
 - (ii) Austin Seven Production Cars. Cars will be deemed to be Austin Seven Production cars for the purpose of this event if they comply with (i) and the following conditions are met:
 - a) Cars must have bodies (or reproductions thereof, but not grp) by the Austin Motor Co. 1922-1939 fitted as standard equipment to Austin Seven cars, proprietary coach built bodies of the era included.
 - b) Cars must be fitted with braking systems on all four wheels or two independent braking systems acting on front wheels simultaneously, the other on rear wheels simultaneously.
 - c) Cars must be fitted with Austin Seven front axle and stub axles with unmodified lockstops.
 - d) Cars must be fitted with overall gear ratios to the original specification.
 - e) Cars must be fitted with Austin Seven inlet/exhaust manifolding.
 - f) Cars must be fitted with Austin Seven wheels to the original factory specification for that model and a spare wheel must be carried.
 - (iii) All cars in Classes i) - iv) must be fitted with original Austin Seven wheels appropriate for the type and model of car entered. Any car not complying with this regulation will be reclassified as a demonstration car, class v).
 - (iv) Seating. For this event Paragraph T9.2 of the MotorsportUK's General Regulations (two fixed seats for Driver and Passenger, the rearmost part of which must not be behind the rear axle) will apply to all vehicles in Class iv). All cars running in Classes i) – iii) must have two front seats AND a passenger 12 years of age or over in the front passenger seat. Children in the rear seats of saloons must be 2 years or older, and all children under the age of 12 years or 135cm in height must be restrained in an appropriate child restraint (MotorsportUK's Yearbook 2019 T4.1.6).
 - (v) It is recommended that cars should be fitted with an extra throttle return spring, that the battery be secured, and that a fire extinguisher and spill kit be carried.
 - (vi) Have any wet batteries in the driver/passenger compartment located behind the base of the drivers/passenger seat and enclosed in a securely located leak-proof container in accordance with Clause J5.14.1

 - a) *Under no circumstances may dogs or any other animals be taken onto the property.*
 - b) *All Competitors must remain within the Stipulated Areas*
